9. The Organization does not directly or indirectly engage in or support any terrorist activity. Neither the Organization nor any Affiliate, nor any officer or director of the Organization or any Affiliate, is included on any lists of terrorists or terrorist organizations compiled by the United States government or any other national or international body (the "Lists"), including but not limited to (i) the U.S. Treasury Department's Specially Designated Nationals List, (ii) the U.S. State Department's Terrorist Exclusion List, (iii) the United Nations List Pursuant to Security Council Resolution 1390 (2002) and Paragraphs 4(B) of Resolution 1267 (1999) and 8(C) of Resolution 1333 (2000), and (iv) the European Union List Implementing Article 2(3) of Regulation (EC) No 2580/2001 on Specific Restrictive measures Directed Against Certain Persons and Entities with a View to Combating Terrorism.
10. If the Organization receives a Contribution from USS, it will use the proceeds of the Contribution solely for its charitable or educational purposes and will not distribute the proceeds to any other person. The Organization will not distribute the proceeds of the Contribution to, or use it to benefit, directly or indirectly, any individual or organization that is engaged in or supportive of terrorism (including but not limited to any individual or organization included on the Lists), and the Organization has adequate procedures in place to ensure this result.
11. If the Organization receives a Contribution from USS which is to be distributed or disbursed in periodic installments, the Organization agrees to submit status reports to USS at such times as may be requested by USS. These reports shall show the progress being made by the Organization in completing the project or in achieving the goals for which the Contribution was made. If USS determines, in its sole discretion, that (i) satisfactory progress is not being made toward completing such project or achieving such goals, or (ii) the activities undertaken by the Organization with the funds contributed by USS are not consistent with USS's understanding of the project, then USS reserves the right to discontinue any further funding. In recognition of the foregoing, the Organization agrees that it will not incur any commitments or take any action in reliance upon the receipt of any such further funding.
12. The Organization acknowledges and agrees that if the Organization receives a Contribution from USS, USS may, at its option, publicly disclose such Contribution, either in a press release or otherwise, and include information regarding such Contribution in its periodic public reports.
13. The Organization acknowledges and agrees that the execution and delivery of this Certificate, or any application for a Contribution, does not necessarily entitle the Organization to a Contribution from USS, and USS may deny or withhold the Contribution for any reason in its sole and absolute discretion. All decisions made by USS regarding the Contribution are final.

- 14. The Organization agrees to supply any additional information or documentation as may be requested by USS in connection with the Contribution and this Certificate. In addition, the Organization agrees to permit USS to review and audit its financial records and statements upon request.

- 15. It is understood that USS will rely upon this Certificate when making its decision on the proposed Contribution to the Organization. All information contained in this Certificate, and in any other documents submitted to USS in connection with the Contribution, is accurate, true and complete. If, at any time, USS determines that any such information is incorrect, inaccurate or incomplete, or the Organization breaches any of its agreements set forth herein, then (i) no additional funds will be disbursed by USS to the Organization, and (ii) the Organization will immediately repay to USS all funds previously disbursed to it by USS.
