# Safety First & Environmental Excellence

Air quality compliance and improvement activities are key to #USSteel's environmental stewardship efforts, and are dedicated to keeping our air clean right here in Pittsburgh at Mon Valley Works.

Recently, Jeff Kotula, President of the Washington County Chamber, authored an op-ed highlighting the exciting findings of PGH Works Together's recent study, "Clearing the Air 4.0."

Utilizing U.S. Environmental Protection Agency (EPA) data from 2022, the report found that Pittsburgh region's air quality is improving year after year. Other key findings in the report include:

- The region's average level of microscopic soot (PM2.5) continues to decline. The PM2.5 level at the Liberty air monitor (near U. S. Steel's Clairton Plant), which is used to measure Allegheny County's compliance with the Clean Air Act, has met EPA standards for years, declined 7% in 2022 compared to 2021, and has dropped 23.2% over the past decade.
- Allegheny County has been in compliance with all EPA standards for two consecutive years for the first time ever.
- The **Pittsburgh region is one of the cleanest major metro areas for ozone**, having less ozone than 74% of the 50 largest metropolitan regions in the country.

There is still more work to be done to continue to improve air quality, but #USSteel is proud to play a role in keeping our air clean — and will continue to support the region.

The Company may also file other documents with the SEC regarding the proposed transaction. This communication is not a substitute for the Proxy Statement or for any other document that may be filed with the SEC in connection with the proposed transaction. The proposed transaction will be submitted to the Company's stockholders for their consideration.
